Our water source is from a well drawing from the Miocene Formation Aquifer. The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The well for the Stone County Utility Authority have received a lower ranking to contamination.

Period Covered by Report

We routinely monitor for contaminants in your drinking water according to federal and state laws. This report is based on results of our monitoring period of January 1st to December 31st, 2022. In cases where monitoring wasn't required in 2022, the table reflects the most recent testing done in accordance with the laws, rules, and regulations.

VIOLATIONS

During 01/01/2014 - 12/31/2022, we did not monitor or test for Uranium and therefore cannot be sure of the quality of our drinking water during that time.

During April 2022, we did not complete all monitoring or testing for bacteriological and Chlorine contaminants and therefore cannot be sure of the quality of our drinking water during that time. We were required to take 1 sample and took none. We have since taken the required sample that showed we are meeting drinking water standards.
